

EXPLANATORY NOTES

1. If the Cooperative is required to install a pole for the exclusive purpose of rendering outdoor lighting, then the consumer-member will be required to pay, prior to construction, a non-refundable construction charge of the amount set forth in the pole section below.
2. In the event the Cooperative is requested to replace an existing cooperative-owned mercury vapor, high pressure sodium, or metal halide fixture that is operational with an equivalent LED fixture, then the consumer-member will be required to pay the Cooperative \$150.00 for each existing 150W – 250W fixture to be replaced and \$200.00 for each existing 400W – 1,000W fixture to be replaced.
3. In the event the Cooperative is required to replace an existing cooperative-owned lighting fixture requiring greater height than that which is achievable on existing poles, then the consumer-member will be required to pay the Cooperative a construction charge to cover the cost of rearranging facilities.
4. The consumer-member may be required to reimburse the Cooperative for any maintenance work which is required because of vandalism.

5. If the consumer-member requests a change in a lighting fixture within one year of initial installation a non-refundable charge of \$200 will be assessed. If a member requests that a lighting fixture be disconnected or reconnected temporarily (for less than one year), then a non-refundable charge of \$135.00 will be assessed.
6. Wiring requirements for outdoor lighting.

Installation of Wiring for Lights - If a light fixture is installed where no underground streetlight wire is available or on a pole without low voltage power, new wiring must be installed for the light. Installing this wiring and transformer (if needed) would require a one-time fee as detailed below.

- a. Residential Neighborhoods – Underground streetlight wiring is available only in areas served by Flint's underground distribution system where the underground streetlight cable is buried in the same trench with the distribution system. A construction charge will be assessed in the amount of \$5.50 per foot for trenching outside of the same trench as the distribution system. Where paving or other obstructions exist, the consumer-member will be required to perform all trenching, install duct furnished by the Cooperative, backfill and complete the paving to the mutual satisfaction of all parties concerned.
- b. Apartment Complexes & Commercial Establishments – A construction charge of \$5.50 per foot for trenching will be assessed for all underground streetlight wiring.
- c. Where paving or other obstructions are currently present, or may become a conflict in the future, underground streetlight wiring shall be placed in conduit either by trenching, open ditch or directional boring. Where conduit(s) are installed by trenching or open ditch to eliminate conflict with pavement or obstructions, a cost adder of \$3.20 per foot shall be applied to 6(a) and 6(b) above. When directional boring is used to place conduit, the cost of underground wiring in 6(a) and 6(b) above shall be increased to \$15.50 per foot for sections installed by directional boring method.

In lieu of charges set forth in Section 6(c), consumer may perform all trenching or boring, install conduits or ducts, backfill and pave; provided the materials and installation satisfactorily meets requirements set forth by Cooperative. Upon acceptance by Cooperative, consumer-member installation of conduits and duct shall become property of and be maintained by the Cooperative.

- d. Aerial wiring for lighting is available in locations with existing overhead power lines. The cost to install aerial wiring for lighting is \$1.60 per foot with a \$160.00 minimum charge. If there are any trees that need to be trimmed or removed to allow for the installation of aerial wiring, the member would be responsible for this work.
- e. If a transformer is required to be installed for the purpose of providing power to a light, the installation cost shall be:

Pole Mount Transformer = \$1,500.00

Pad Mount Transformer = \$2,700.00

SCHEDULE LM-10

LOAD MANAGEMENT RIDER

PURPOSE

To provide revenue for patron's electric service and capital from the patrons. In compliance with cooperative principles and the Corporation's bylaws, revenue received which is in excess of operating cost and expenses, is patronage capital. All monies in excess of the cost of providing electric service are capital, at the moment of receipt, and will be credited to each patron's individual capital account.

AVAILABILITY

This schedule is available in conjunction with service under these Flint EMC Rate Schedules:

General Service Rates 2, 3 and 8
Large General Service 7
Large Industrial Service Rate 39
Customer Choice Rate 44

Where the member (or a third party provider) has available generation which can provide for electric service to the member business/industry or the member agrees to reduce its electric demand by at least 100 kW or 50%, whichever is greater, without the use of generation during peak load hours in the summer. The availability of credits under this Rider is contingent upon the member's load reduction resulting in a corresponding reduction in Flint's top 10 and Top 5 billing demand hours from its wholesale power supplier and transmission provider.

When using generation to reduce demand under this Rider, the member or a third-party provider must own, provide and maintain generation, communication, metering and interconnection equipment agreed upon by the member and Flint EMC needed to assist in demand reduction. Member must sign an interconnection agreement with Flint EMC stating specifics of the responsibilities of the member in regard to the interconnection between member facilities and Flint EMC's distribution system. Safe interconnections and operation are paramount and all tenets of IEEE 1547 must be met. All safety-related interconnection equipment, communication and metering are the responsibility of the member and/or third party provider.

When the member agrees to reduce demand under this Rider without the use of generation, the member must provide and maintain the communications equipment agreed upon by the member and Flint EMC needed to receive notifications of load management periods.

DEMAND REDUCTION

Credits are available under this Rider for demand reduction during the top 10 and top 5 peak hours coincident with the wholesale power supplier's system and transmission provider's system, respectively. If the member elects to use qualified generation, it must meet requirements set forth by Flint EMC. The demand reductions typically occur in the summer months of May through September from 2 pm to 8 pm, however, it is possible for demand reductions to occur at any point during the year. Typically, demand reduction will not be called upon for more than 120 hours each calendar year. Member must provide outputs from generator to drive Flint EMC's metering equipment to verify power produced by generator.

ANNUAL CREDIT

Member (or the third party generation provider) will be eligible to receive a single annual credit in November each year for every kW removed from the member's demand during the top 10 peak hours in the summer months, according to this schedule:

2023	\$63.66 per kW-year
2024	\$64.62 per kW-year
2025	\$26.31 per kW-year

ANNUAL CREDIT

Member (or the third party generation provider) will be eligible to receive a single annual credit in November each year for every kW removed from the member's demand during the top 5 peak hours during the year, according to this schedule:

2023	\$23.27 per kW-year
2024	\$25.59 per kW-year
2025	\$26.51 per kW-year

DETERMINATION OF DEMAND REDUCTION FOR CREDIT

The following method will be used for the determination of kW demand reduction:

The determination of the credit will be solely and exclusively made by Flint EMC each November. The level of reduction will be determined using the member's average kW of demand compared to the demand that would otherwise have occurred during the top 10 and top 5 peak hours which will be determined by the wholesale power supplier and transmission provider, respectively. Flint EMC retains the exclusive right to determine the member's load reduction by analyzing member data gathered by the metering equipment installed at the member's location. If the generation does not run or the member fails to reduce demand during one or more of the top 10 or top 5 peak hours, the credit will be prorated based on the hours of generator operation or load reduction.

NOTIFICATIONS OF LOAD MANAGEMENT PERIODS

Flint EMC will use diligent commercially reasonable efforts to predict the annual system peak hours and notify the member and/or third party provider in advance. However, Flint is not able to guarantee an accurate prediction, or that adequate notice will be provided. Notification by Flint EMC will be provided to the member (and/or the third party generation provider) by direct telephone communications, email or automated signal, as mutually agreed. The member will hold Flint EMC harmless in connection with its response to notification.

The member assumes responsibility for and shall indemnify, defend, and hold Flint EMC harmless against all liability, claims for damage costs, and expenses for injury, including personal injury, or property damage to member and its officers, employees, agents and invitees on account of the use of this rider on the member's side of the meter, delivery point, or service point.

SCHEDULE NEM-25

NET ENERGY METERING RIDER

PURPOSE

The purpose of this rider is to establish the methods and procedures for determining credits, payments, and charges applicable to Members Flint EMC who own and operate a distributed generation facility as defined in Flint EMC's Distributed Generation Facility Policy.

AVAILABILITY

This rider is available to any Member of Flint EMC owning and operating a distributed generation facility, as defined in Flint EMC's Distributed Generation Facility Policy, who executes a Net Metering and Interconnection Agreement with Flint EMC.

The capacity of a distributed generation facilities used by residential customers shall not exceed 10 kW and the capacity of a distributed generation facility used by a non-residential customer shall not exceed 100 kW. The total committed capacity of all generators subject to this Rider shall not exceed 0.2 percent (0.2%) of Flint EMC's annual peak demand for the previous year.

DEFINITIONS

The following words and terms shall have the following meanings unless the context clearly indicates otherwise:

"Billing Period" means, as to a particular customer, the time period between the dates on which Flint normally reads the retail service meter for billing purposes.

"Bi-directional Meter" is a meter capable of measuring (but not necessarily displaying) electricity flow in both directions.

"Bi-directional Metering" means measuring the amount of electricity supplied by Flint EMC and the amount fed back to Flint EMC by the Member's distributed generation facility using a single meter.

"Customer Generator" means the owner and operator of a distributed generation facility.

"Distributed Generation Facility" means a facility owned and operated by a Member of Flint EMC for the production of electrical energy that:

1. Uses a solar Photovoltaic system, fuel cell, biomass source or wind turbine;
2. Has peak generating capacity of not more than 10 kW for a residential application and 100 kW for a commercial application;
3. Is located on the Member's premises;
4. Operates in parallel with Flint EMC's distribution facilities;
5. Is connected to Flint EMC's distribution system on either side of retail service meter; and
6. Is intended primarily to offset part or all of the Member's requirements for electricity.

“**Excess Net Energy**” is the difference between the electricity generated by the Member’s Distributed Generation Facility and the electricity consumed by the Net Metering Customer during the billing period.

“**Fixed Charge Rate**” shall be a percentage factor that includes components for the recovery of operations and maintenance expense, administrative and general expense, taxes, depreciation and the cost of capital which are all associated with owning and operating the utility plant necessary for interconnection and for the provision of Net Metering pursuant to this Rider. The fixed charge rate may be modified at any time by Flint EMC to reflect current costs.

“**Net Metering Customer**” means a Member generator receiving net metering service.

“**Net Metering**” means measuring the difference between electricity supplied to a Net Metering Customer from the electric grid and the electricity generated and fed into the electric grid by the Net Metering Customer, using a single bi-directional meter or an additional single direction meter.

CONDITIONS OF SERVICE

There must be a written Net Metering and Interconnection Agreement with the Member and the Member must have met all of the conditions of interconnection contained in the Distributed Generation Facilities and Net Metering Policy.

DISPOSITION OF ENERGY

If the electricity consumed by the Net Metering Customer during the billing period exceeds the electricity generated by the Member’s Distributed Generation Facility during the billing period, then all electricity generated by the customer generation shall be deemed to have been used by the Net Metering Customer. If the electricity generated by the Member’s Distributed Generation Facility during the billing period exceeds the electricity consumed by the Net Metering Customer, then the excess net energy shall be purchased by Flint EMC at rates as provided under the Purchase Rate section of this Rider.

RATES AND CHARGES FOR NET METERING SERVICE

Each Net Metering Customer shall be charged for electric service under that rate schedule which would otherwise be applicable if the customer was not a Net Metering Customer. In addition, each Net Metering Customer shall pay a monthly service charge based upon the incremental cost of metering equipment times Flint EMC’s monthly Fixed Charge Rate. If applicable, there may also be facilities charges reflected in the Member’s Net Metering and Interconnection Agreement.

PURCHASE RATE

The rates paid for the excess net energy purchased by Flint EMC shall be based upon the EMC’s avoided cost of energy. The avoided cost of energy shall be applied monthly as follows:

The rates as quoted herein may be adjusted at any time by Flint EMC.

TERM OF SERVICE

The term of service under this rider shall be the same as that under the Net Metering and Interconnection Agreement.

SCHEDULE REC-1

RENEWABLE ENERGY CERTIFICATE RIDER

PURPOSE

The purpose of this rider is to establish the methods and procedures for determining payments and charges applicable to Flint EMC members who desire to reduce their carbon footprint through the retirement of renewable energy certificates (RECs).

AVAILABILITY

Available to all non-residential members in Flint EMC's service area.

The availability of RECs for purchase under this Rider will be subject to the total amount of RECs available to Flint EMC based upon existing power supply contracts Flint EMC has with REC-producing generation sources as well as RECs committed to other members under this Rider or other rate schedules. Flint EMC makes no guarantee that RECs will be made available to new or existing participants, with the exception of those reserved under a Long-Term Reservation.

CONDITIONS OF SERVICE

Member can opt for any percentage of energy usage, up to 100%, to be covered under this Rider. RECs may come from solar, wind, biomass, or other sources. There is no guarantee that RECs retired on behalf of a Member will come from any particular source.

Certificates showing the total RECs retired on Member's behalf will be prepared at the beginning of the calendar year for the previous calendar year, unless other terms are agreed upon by Member and Flint EMC.

Member will need to provide notice of carbon goals or renewable energy requirements for each year by December 31st of the previous year. Without sufficient notice, Flint EMC cannot guarantee availability of this Rider.

Any forecasted changes, upgrades, or growth to a Member's electric load, beyond weather related fluctuations in energy usage, needs to be shared with Flint EMC for Members using this Rider. Any desired changes to the percentage of energy usage covered under this Rider must be communicated with Flint EMC at least three (3) months in advance of when the desired change is requested.

Member understands and agrees that any energy offset with RECs through this Rider will be retired on behalf of the Member by Flint EMC and/or Green Power EMC and will not be able to be sold or traded on any market.

ANNUAL ADDER

Member will pay an additional charge for every kWh they purchase from Flint EMC that they want to be covered under this Rider. This adder shall apply for all RECs during the calendar year and is subject to change annually based on market pricing.

LONG-TERM RESERVATIONS

For any Member that wants to make plans for future years, a Long-term Reservation can be used so that Flint EMC will hold the appropriate RECs on behalf of the Member. The price paid for the entire length of the reservation is based on the Annual Adder of the year the Long-term Reservation is made and also includes an inflation percentage adder. Any Long-term Reservation can be ended early with a three (3) month notice to Flint EMC.

2 years	Annual Adder + 2.5%
3 years	Annual Adder + 5%
5 years	Annual Adder + 10.5%

SPECIAL EVENT PURCHASE

One-time purchases of RECs for a special event or occasion can be made using the Annual Adder price above in addition to a \$40 service fee.

TERMS OF PAYMENT

The above charges are subject to applicable taxes and are due on or before the due date printed on each billing statement. In the event payment is not received by 5:00 P.M. on the due date, there will be a five-percent (5%) late payment fee added.

Payment for RECs can be made on each monthly bill based on the kWh purchased during that billing period. A single payment at the end of the calendar year can also be made as well. Late payments for RECs will delay the retirement and certificate creation on behalf of the Member and could cause RECs to be forfeited.

RESIDENTIAL LOAD MANAGEMENT RIDER

PURPOSE

To provide revenue for patron's electric service and capital from the patrons. In compliance with cooperative principles and the Corporation's bylaws, revenue received which is in excess of operating cost and expenses, is patronage capital. All monies in excess of the cost of providing electric service are capital, at the moment of receipt, and will be credited to each patron's individual capital account

AVAILABILITY

Available to all residential consumers in the service area of Flint EMC.

APPLICABLE

This schedule is applicable to and becomes an additional rider to each standard electric service rate schedule that serves members which participate in Flint EMC's Smart Select load management program.

TYPE OF SERVICE

Single-Phase or Three-Phase, 60 Hertz, at available secondary voltage.

ANNUAL CREDIT

Members that enroll in Flint's Smart Select program will receive a one-time \$36 credit after Flint EMC installs a load control switch on the member's central air conditioning unit(s), water heaters, and/or pool pumps.

All active members participating in Flint EMC's Smart Select program who have switches on their qualifying devices may receive a credit after successful operation of load management during the months of May, June, July, August, September, and October. Flint EMC will typically operate load management during those months previously listed Monday through Sunday beginning at 2 PM Eastern Standard Time and ending at 8 PM Eastern Standard Time. The amount of the annual credit is \$25 per participating member.

The load management switch must have been in place during the full usage period for which the load management credit is given. Flint EMC will remove the participating member from the Smart Select load management program if Flint EMC can no longer communicate with the member's load control switch(s) or has verified the load control switch is no longer connected to the qualifying device(s). Upon removal from the Smart Select load management program member will no longer receive the annual credit. Credit will be given only to those members whose accounts are active at the time the bill is rendered.

SCHEDULE WPCA

WHOLESALE POWER COST ADJUSTMENT RIDER

PURPOSE

To provide revenue for patron's electric service and capital from the patrons. In compliance with cooperative principles and the Corporation's bylaws, revenue received which is in excess of operating cost and expenses, is patronage capital. All monies in excess of the cost of providing electric service are capital, at the moment of receipt, and will be credited to each patron's individual capital account.

AVAILABILITY

This schedule is applicable to and becomes a part of each electric service rate schedule of Flint EMC in which reference is made to "Schedule WPCA" or "Fuel Cost Adjustment".

The Wholesale Power Cost Adjustment calculation is to be made on a monthly basis and adjustments made at the discretion of Flint's Board of Directors.

Except as approved by the Board of Directors to deal with extraordinary future expenses related to power costs, to accommodate an over-recovery of power cost that extends beyond the period contemplated by this formula, and for other purposes, each metered kWh of energy sold by Flint EMC under an applicable rate schedule shall be increased (or decreased) by the amount computed as follows:

Formula: $WPCA = ((PC_A + \sum PC_P - \sum WPCA\$_A) \div \sum kWh_P) - \$0.08528$;

Where: $WPCA$ = Wholesale Power Cost Adjustment (in \$ per kWh);

PC_A = Actual wholesale power cost for the current month;

$\sum PC_P$ = Sum of projected wholesale power costs for the next eleven months;

$\sum WPCA\$_A$ = Sum of actual WPCA revenues collected for the current month and the previous eleven months;

$\sum kWh_P$ = Sum of actual kWh sales for the current month and projected kWh sales for the next eleven months; and,

$\$0.08528$ = Wholesale power cost included in calculation of base rates

EFFECTIVE: Bills effective January 1, 2025
